Is this announcement going to be replacing the HIV prevention funding that is currently expiring in December 2024? If so, can you explain the substantial decrease in funding available per award? We are currently funded at just over which we would be eligible (as a tier 3 jurisdiction) is \$125,000, while the anticipated award is \$71,429. Is this reduction due to funding at the federal level, or is DSHS changing the way federal funding is being dispersed to local jurisdictions? This is a quite significant reduction in funding. This anticipated amount of \$71,429 is not enough to fund even one position, let alone the infrastructure that would be required to support the staff. Consequently, I do not know if we will be permitted to apply for this funding, and goodness knows we need it. The has one of the highest syphilis rates in the state, and our HIV numbers have been on the rise this year. We've already been told our DIS funding is not being renewed due to funding cuts made during debt ceiling negotiations. We desperately need the services in our area, and we're working really hard to care for our community with what we do have.
