1	Exhibit B, DFPS Grant Uniform Terms and Conditions	<p>I am reaching out regarding one of the questions I posed regarding RFA No. HHS0013406. Regarding Exhibit B DFPS Grant Uniform Terms and Conditions, I see that the response posted in the Questions and Answers Attachment to Addendum 2 states that Exhibit B is saved as a Portfolio, which can be opened by going to View, Portfolio, Details from the PDF toolbar menu. However, when I tried this, it still did not work. I checked with our IT department, and it appears that the PDF portfolio is using Flash, which is no longer supported by Adobe.</p> <p>I realize that the deadline for submitting questions has now passed, however, I am hoping that you can assist me with accessing the rest of the document so we can ensure we are able to agree to all of the terms and conditions outlined in Exhibit B prior to submitting our application.
