We would like to clarify if that is still in the criteria for this grant?	Section 3.2 Application Screening Requirements identifies the Applicant must be classified as a Rural Hospital. The definition of a Rural Hospital can be found in Section 1.2 Definitions and Acronyms. The RFA does not state there is a limit on the number of Rural Hospital Applicants within a county.

Section 5.1 Grant Funding Source and Available Funding states that this grant is time-limited and that the allocation methods for the funds will vary from year-to-year. There is no guarantee of future funding beyond the duration for which the funding is

			awarded.
19	General	Is this grant paid out initially and then we submit expenses or vice versa?	This grant does not use a cost reimbursement methodology for its grant payments. Section 5.5 Payment Method identifies how the grant funds will be paid upon execution of the Grant Agreement resulting from this RFA. According to this section of the RFA, a lump sum payment will be made once the System Agency receives and accepts the Hospital Stability Improvement Plan.
20	General	We are assuming the hospital license previously held by a separate health system. The license carries the responsibility for repaying IGT recoupments which is threatening our ability to go forward. Is repayment of these recoupments a potential use of the subject grant funding?	Grantees shall only use grant funds for expenses or costs for goods or services to foster hospital improvement and financial stabilization in accordance with the respective HHSC approved Hospital Stability Improvement Plan (see Section 2.5 Program Requirements). Section 5.1, Grant Funding Source and Available Funding states that grant funds must only be used for actual, allowable, and allocable expenses that occur within the Project Period, and grant funds must not be used for spending or costs incurred prior to the effective date of the Grant Agreement.
